We distribute food boxes for clients to pick up on four days of a food distribution week each month. Food boxes contain approximately 50 nutritious food items, approximately one week's groceries for a family of four. Also, fifteen teams of volunteers deliver food to some 90 homebound recipients. All families are screened once a year to insure financial eligibility and need. Over 200 volunteers from congregations and groups throughout the community help with distribution days. Estimated food poundage distributed through SHARE is 135,000 lbs a month. The gleaning program harvests donations of fresh produce from approximately twenty-five local farms. Volunteers from churches, businesses, families and food bank recipients work together in the fields to collect fresh, edible produce not gathered at regular harvest times.

We distribute free clothing and household items every week except for the week of our food distribution. The clothing room serves about 250 people a month. About 8500 lbs. of clothing and household goods are received here each month from the greater Carlisle community.

The Chaplaincy program serves the spiritual needs of over 850 individuals on a monthly basis. The program covers the County Nursing Home as well as the County Prison. The Chaplain holds weekly bible studies as well as counseling individuals as needed.
